**1. Acceptance Deposit**

- An acceptance deposit of **GBP 2,415** must be paid within two weeks of the date stated on the offer letter to secure the student's place.
- Failure to pay the acceptance deposit by the given deadline may result in the place being released to accommodate other applicants.
- The acceptance deposit is comprised of a **GBP 1,449** non-refundable Registration Fee and **GBP 966** Student deposit (for any examination fees (Level 2 Diploma and A-Level exams), any fines, outstanding debts, possible damage to rooms, etc.).
- At the end of a student's course, any amount remaining from the Student deposit will be donated to the ISCA Development Fund, unless a specific request for a refund is received in writing. No refund is given for requests made more than 3 years after the student has left the school.
- The acceptance deposit is separate from tuition and boarding fees. Outstanding fees for academic year 2025/26 will be due on receipt of the acceptance deposit and must be paid by the date indicated on the invoice.

### **2. Access to Central Saint Martins - Creative Practice Programme**

#### **2.1. Creative Practice Programme**

The Creative Practice Programme is devised and taught by experienced Foundation tutors at the college of Central Saint Martins.

The weekly Creative Practice sessions complement the second year A Level and Portfolio curriculum.

**The Creative Practice Programme tuition fee is covered by ISCA including coach transport to and from the Central Saint Martins campus.**

### **3. Enrichment Programme**

- a) During their time at ISCA, students will have the opportunity to take part in some external trips and enrichment activities arranged by the School. Where necessary separate charges will be made for such activities.
- b) Although the additional charges for ISCA's Enrichment Programme are expected to exceed £300 in any academic year, ISCA is committed to absorbing any additional costs.

### **4. Materials**

- a) All new students are supplied with a starter kit containing essential art materials at the beginning of their course.
- b) A fabric, photographic paper and printing allowance is provided to each student for the term in line with the curriculum and for use during classroom teaching. Each term, the student will be given a printing allowance of £10. After this has been used, the following charges (at cost price) will apply for printouts and for copying:

Black A4 5p per print/copy

Colour A4 12p per print/copy

Black A3 10p per print/copy

Colour A3 25p per print/copy

- c) Any additional materials required by a student for a project is at the cost of the individual.
- d) All books provided are on loan and students will incur a cost if they damage or fail to return an item.

### **5. AS and A level Examination Fees**

Initial examination fees are covered by the student deposit. However, any exam fees for subjects not taught at ISCA or re-sits will be charged to the student.

### **6. English Language & Learning Support**

- a) Additional private language tuition may be required for students who join ISCA on the minimum language requirement of IELTS 4.5.
- b) Additional tuition requirements, and charges incurred for private English language tuition and additional learning support, will be determined on an individual basis.
- c) External testing costs, such as IELTS, will be charged to the student account.

### **SECTION 2 | CHANGES, WITHDRAWALS & REFUNDS**

#### **1. Failure to take up a place**

Parents must provide a written explanation for a student's failure to take up a place. A partial refund will be given for the following:

##### **1.1. Refusal of Student Visa**

A refund of the fees and acceptance deposit paid, minus **GBP 1,449** non-refundable Registration fee, will be given to students who are refused a Study Visa on the following conditions:

- a) The parents send ISCA the original of the visa rejection letter, within 40 days of the decision being made by the Embassy or Consulate.
- b) Claims for refunds more than 40 days after the date of the decision cannot be accepted.
- c) The School will refund only to the account or individual who originally paid the fees.

**Please note:** ISCA reserves the right to withhold all or part of the refund if the refusal of the visa is due to any dishonesty on the part of the student, for example the presentation of fraudulent documents. Any refund in this case is at the complete discretion of ISCA.

##### **1.2. Conditions of Offer**

- a) In the event that the conditions of an offer are not met, the option of deferring to the following course start date will be available.

#### **2. Withdrawal**

Parents must inform the School in writing of any intention to withdraw a student.

##### **2.1. Voluntary Withdrawal**

- a) Voluntary withdrawal prior to enrolment must be made in writing no later than 1 August 2025.
- b) Voluntary withdrawal of students returning for Year 2 of the A Level Programme must be made in writing no later than the 20 March 2026.
- c) A refund of the full fee paid, minus **GBP 1,449** non-refundable Registration fee, will be made on a voluntary withdrawal prior to 1 August 2025.
- d) Voluntary withdrawal after enrolment must be made in writing and one full term's notice given. No refund of Tuition or Boarding fees will be made unless more than two terms have been paid in advance, in which case a refund may be made of any fees paid in excess of these two terms.

##### **2.2. Withdrawal due to illness**

- a) Withdrawal due to illness is subject to the same terms and conditions as voluntary withdrawal (see above).
- b) No refund of Tuition fees where the student is absent from class due to illness and no refund of Boarding Fees will be given where a student is absent due to illness.

**3. Refunds**

Any bank charges will be deducted from the refund. No refund will be given to a student for the following circumstances:

- a) Cancellation due to change in the student's personal circumstances, including illness or a family bereavement. Students are advised to take out insurance against such unforeseen circumstances.
- b) If the student is asked to leave the country by the United Kingdom Authorities, or if the student leaves the UK during term time without consulting the School and is subsequently refused re-entry.
- c) If the student is excluded from ISCA for whatever reason.
- d) If a visa is refused due to any circumstances about which the student deceived the School in his/her application or any circumstances that they failed to declare. This includes:
  - Not holding the qualifications or required fees as claimed.
  - Previous violation of immigration conditions, breaking of immigration rules by student or a conviction in court.
  - If a visa is refused as a consequence of the student not having the minimum attendance required over the period of the course enrolled on at ISCA or of any illegal activities by the student.
  - If the disruption in the student's studies is due to the student's conviction, court proceedings or litigation involving the student.
  - If the disruption in the student's studies is due to any other breach of his/her visa conditions or terms and conditions of enrolment.
- e) In the event of force majeure or similar circumstances, leading to the closure of the School during term time, there shall be no refund of fees already paid.
- f) No other refunds of tuition or supplementary fees will be given.

**4. Non-Payment**

- a) The school reserves the right to refuse admittance to a student until invoiced fees are paid in full. In the event of non-payment, international students will be given a notice period before the school will uphold its responsibility to inform UK Visas and Immigration, which may affect the validity of the student visa.
- b) Students leaving ISCA are required to clear all obligations before final records are released to the next school or university and before any certificates are released.

**5. Exclusion**

If a student is excluded from ISCA for whatever reason, no refund of Tuition or Boarding fees will be made.

### **6. Change of circumstances**

Although day students are not normally permitted, this option may be considered in exceptional circumstances, e.g. on medical grounds. If a student changes from a boarding to a day student mid-term no refund of boarding fees will be granted.

Additional fees for the remaining academic year will be decided on a case-by-case basis but will include charges for meals taken during the day, and the surcharge on the room for which ISCA is liable.

The rate payable for students who are joining ISCA as a day student is **GBP 1,833 per term**. The fee includes the use of campus facilities, as well as all meals (breakfast, lunch and dinner) taken in the canteen.
